

CLIENT AGREEMENT

This Agreement is made and entered into by and between the Payor ("Client") and Priceless Legacy Company, LLC ("PLC") of 15305 Dallas Parkway, Suite 1000, Dallas, TX 75001. In consideration of the mutual promises and agreements set forth herein, the parties do hereby agree and contract as follows:

1. Acceptance of Agreement; By completing the order form and processing the first payment, the "Client" enters into this agreement and agrees to the terms of this Agreement and the associated PLC Terms of Service.
2. Payment Schedule; When otherwise not paid in full at the time of order, the Client may be provided the option to pay for PLC products and services via scheduled payments. When selected, the Client will be charged based on the following schedule:
 1. Payment #1 processed at the time of the order ("order date")
 2. Payment #2 processed 30 days from the order date (order date + 30 days)
 3. Payment #3 processed 60 days from the order date (order date + 60 days)
 4. Final Payment processed 90 days from the order date (order date + 90 days)

2(a). Final payments will include the balance of the order to include any additional items (e.g., additional books, CDs, DVDs, add-ons, etc.)

2(b). All payments (including the final payment) must be received and paid in full prior to shipping products or releasing the Life Story Book for print.

2(c). Client is responsible for submitting any applicable state and local taxes due based upon taxing authorities.
3. Exclusivity of Process; Client agrees to follow the Priceless Legacy proprietary process exclusively and adhere to the timelines suggested and outlined by PLC.
4. Priceless Legacy agrees to provide (as applicable) the tools, coordination, management, and publishing of its Life Story products. Priceless Legacy's responsibilities will be (but are not limited to):
 - Providing access to the PLC proprietary process and tools to complete the process
 - Providing access to expertise of the PLC graphic artists
 - Transcribing audio and lightly edit files

- Providing an edited transcript of the book text for approval by the Client
- Providing a low-resolution electronic copy of the book layout for approval by the Client (2 reviews- initial review, final review)
- Printing the Life Story Book(s)
- Fulfilling the Life Story Package components as defined by the specifications listed on the order form

5. The Client agrees to:

1. Conduct an initial consultation call with PLC
2. Designate a single point of contact as the primary interface between PLC and the Client and Subject
3. Aid in preparation and scheduling of the Subject (if applicable) for the interview
4. Aid Subject in organizing photos and ensuring the photos are sent for digitization
5. Review and approve book text and book layouts in a timely manner
6. Review the process documentation and understand the associated timeline; once the final approval to print is received by PLC, it is approximately 2-3 weeks to print and deliver to the Client
7. Understand the components of the package the Client is purchasing
